Technology/Food Service: VCA has been serving approximately 400 meals a week.

Instruction: Ms. Kletter

Professional Development: Pupil Free Day for Staff Development was February 12. Teachers completed virtual training via Moodle for administering the Summative ELPAC, planned and scheduled administration, and prepared technology.

Data and Academic Updates: The Summative ELPAC Test will be administered in March. Teachers and families will have the option for remote or in person administration.

Stakeholder Engagement: We are working on a draft letter to send to parents regarding school opening. We will communicate the conditions upon which the campus will open in hybrid, the draft schedule, health and safety measures, testing protocols, and school resources.

Special Education/Intervention Updates Programs and services are continuing with many students meeting IEP goals and expectations. Another student exited from the SPED program, no longer needing speech and language services. We presently have 44 students with IEP's and 5 assessments in progress. Students are coming to school weekly for assessments.
