1. Directors Report

Operations:

Facilities-We are installing Air Scrubbers for each HVAC unit. The cost to the school is about 22k. These should provide protections beyond Covid for environmental allergens and smoke. We have installed a battery back up for the gates. This will enable us to open the gates during a power outage instead of manually opening them. The cost to the school is approx. 3k. We have met all the requirements from the state and county for reopening. The custodians worked with Dennis to prep the classroom doors so he could repaint them.

Technology/Food Service We continue to serve approximately 400 meals a week. We are beginning to plan food service for when students return to campus. We continue to hand out Hotspots to families that need connectivity.

Data and Academic Updates- STAR Reading and Math Growth Report (imbedded in Directors' Report); VCA received WASC Accreditation for 6 years.

Teachers are surveying families during parent teacher conferences to see which students will return to campus for in person instruction in April.

Student Services:

Special Education/Intervention Updates- We presently have 44 students with active IEP's. We are in the process of completing 5 Initials and IEP's will be held next month. We have completed ELPAC testing for our students with disabilities. Students are coming to school weekly for a variety of assessments. We are working on our transition information for fifteen 5th graders and assisting parents when needed. We will hold transition meetings in April and May. The Math group for 5th graders has begun and the teacher is reporting good attendance and engagement. There are 7 students out of fifteen 5th graders that are attending based on their math needs.

We received a notice that some dates needed to be corrected, that was taken care of and sent out on 3/18/21.

Leadership Many students are continuing their activities with Pen-Pal school and are really enjoying it. They are making friends and interacting with students around the world.
